

## 2021 Weekly Legislative Report Joint Budget Hearing Week

During last week's recess week, the House and Senate Appropriations Committees held joint hearings. The hearings began with Governor Brian Kemp on Tuesday, January 19<sup>th</sup> and concluded on Thursday, January 21<sup>st</sup>. Each Statewide Officer, Supreme Court, and State Agencies presented their proposed budgets. The State Economist also presented an interesting presentation on the state of the economy.
